IDAPA 02 TITLE 06 Chapter 22

02.06.22 - NOXIOUS WEEDS RULES

000. LEGAL AUTHORITY.

This chapter is adopted under the legal authority of Section 22-2403, Idaho Code.

001. TITLE AND SCOPE.

01. Title. The title of this chapter is IDAPA 02.06.22, "Noxious Weed Rules".

02. Scope. These rules identify those noxious weeds which have been officially designated by the Director as Noxious Weeds in the state of Idaho, designates articles capable of disseminating noxious weeds, requires treatment of articles to prevent dissemination of noxious weeds and provides authority to designate special management zones for management of noxious weeds.

002. WRITTEN INTERPRETATIONS.

There are no written interpretations of these rules.

003. ADMINISTRATIVE APPEAL.

There is no provision for administrative appeals before the Idaho State Department of Agriculture under this chapter.

004. PUBLIC RECORDS ACT COMPLIANCE.

These rules are public records and are available for inspection and copying at the department.

100. NOXIOUS WEEDS.

01. Designation of Noxious Weeds. The following weeds are hereby officially designated and published as noxious:

- a. Buffalobur (*Solanum rostratum*) Dun.
- b. Canada thistle (*Cirsium arvense*) (L.) Scop.
- c. Common crupina (*Crupina vulgaris*) Cass.
- d. Dalmatian toadflax (*Linaria dalmatica*) (L.) Mill.
- e. Diffuse knapweed (*Centaurea diffusa*) Lam.
- f. Dyers woad (*Isatis tinctoria*) L.
- g. Eurasian watermilfoil (*Myriophyllum spicatum*)
- h. Field bindweed (*Convolvulus arvensis*) L.
- i. Henbane (*Hyoscyamus niger*) L.
- j. Johnsongrass (*Sorghum halepense*) (L.) Pers.
- k. Jointed goatgrass (*Aegilops cylindrica*) Host.
- l. Leafy spurge (*Euphorbia esula*) L.
- m. Loosestrife (*Lythrum salicaria*) L.
- n. Matgrass (*Nardus stricta*).
- o. Meadow knapweed (*Centaurea pratensis*).
- p. Miliium (*Milium vernale*).
- q. Orange hawkweed (*Hieracium aurantiacum*) L.
- r. Musk thistle (*Carduus nutans*) L.
- s. Perennial pepperweed (*Lepidium latifolium*) L.
- t. Perennial sowthistle (*Sonchus arvensis*) L.
- u. Poison hemlock (*Conium maculatum*) L.
- v. Puncturevine (*Tribulus terrestris*) L.
- w. Rush skeletonweed (*Chondrilla juncea*) L.
- x. Russian knapweed (*Centaurea repens*) L.
- y. Scotch broom (*Cytisus scoparius*) (L.) Link

- hh. Yellow hawkweed (*Hieracium pratense*) Tausch
- ii. Yellow starthistle (*Centaurea solstitialis*) L.
- ii. Yellow toadflax (*Linaria vulgaris*) Mill.

02. Designation Of Articles Capable Of Disseminating Noxious Weeds. The following articles are designated by the Director as capable of disseminating noxious weeds:

- a. Construction equipment, road building and maintenance equipment, and farm machinery.
- b. Trucks and motorized vehicles.
- c. Grain and seed.
- d. Hay, straw and other material of similar nature.
- e. Nursery stock.
- f. Feed and seed screenings.
- g. Fence posts, fencing and railroad ties.
- h. Sod.
- i. Manure, fertilizers and material of similar nature.
- j. Soil, sand, and gravel.

101. -- 199. (RESERVED).

200. TREATMENT OF ARTICLES.

01. Duty. It shall be the duty of every person, before removing any article from any place that is infested with noxious weeds or before moving the article Onto any public roadway, to enclose, clean, or treat the article in a manner that will prevent the spread of noxious weeds.

02. Treatment. No article containing noxious weed propagules shall be sold or furnished to any person within this state, until it has been treated in a manner sufficient to eliminate all noxious weed propagating capability except when sold or furnished to a person for the purpose of destroying the viability of the noxious weed propagules.

300. SPECIAL MANAGEMENT ZONES.

Special management zone designation shall define the geographical location of the zone, identify noxious weeds which will receive modified control, and delineate the modified control.
